# NEF6393 Contemporary Heavy Vehicle Access Decision Making for Road Managers

The Board was updated on project scoping and the findings of member and National Heavy Vehicle Regulator consultation. With the aim to make a HVAMS system available to Australian and New Zealand road managers, particularly in local government, the Board approved a variation of the project, including additional investment and a delineation of tasks and responsibilities between Austroads and members. On that basis, Austroads will finalise the inception report and implementation plan.

# BN2019 Safety at Road Worksites (harmonisation of temporary traffic management practice)

The implementation phase of the project is progressing well with operational activities underway and training materials largely completed.

## **ASP6089 Technical Specifications**

Progress is being made on Austroads Technical Specifications for road and bridge construction. All Austroads Technical Advisory Group members have committed to adopt the specifications. Challenges to adoption are being collected and will be reported to Board.

#### ASP6030 Austroads Road Asset Data Standard

The project has been undertaking engagement activities with local road managers to refine the Knowledge Sharing Platform and support road managers to procure data and use cases. Work is underway towards greater local government involvement. Board members will nominate members for the Road Asset Data Standard Implementation Task Force.

# Other priority projects

The Board noted progress on priority projects including: Austroads Safety Hardware Training and Accreditation Scheme training; Assessing Fitness to Drive implementation; and Advanced Driver Assistance Systems guidance.

#### **EAS6403 Stocktake of Environment Initiatives**

The Board approved the publication of a high-level summary of the environment and sustainability initiatives of Austroads eleven member agencies.

# Transport Certification Australia (TCA) Strategic Projects

The board was updated on TCA's priority projects. The Board noted the paper on the operating model for the Technology and Data Framework that has been proposed as part of the Heavy Vehicle National Law Review.
